Announcement on Anti-Bribery Policy and No Gift Policy from the performance

of duties for fiscal year 2024

According to the Constitutional Prevention and Suppression of Corruption Act B.E.2561, Section 128, paragraph one, prohibits any public official from receiving property or anyother benefit that may be calculated as income from anyone. other than assets or legitimateinterests. rules or regulations issued by virtue of the provisions of law, except for the receiptof assets or other benefits by virtue of the rules and amounts prescribed by the Board ofDirectors. The NACC stipulates and the Code of Ethics for Police Officials B.E. 2564 (2021)Honesty and Integrity Comply with legal obligations Transparency of the Royal Thai PoliceRefrain from demonstrating behavior that implies exploitation or abuse and is responsible forhuman rights duties. Article 1.1 All government agencies shall declare as agencies that all government officials do not accept gifts and gifts of all kinds from performing their duties (No Gift Policy) Therefore, in order to prevent conflict of interest, bribery, gifts, gifts or any other benefits that affect the performance of duties, the Anti-Bribery Policy and No Gift Policy from the performance of duties have been established as follows: Article 1 This Notice "Supervisor" means the authority to command, supervise, monitor and inspect the police officers under him. "Bribe" means property or

any other benefit given to a person to induce him to act ornot to act in office. Whether it is rightful or unlawful with duty./"Performance of duties" means:

"Performance of duties " means an act or performance of duties by a public official ina position appointed orassigned to perform any duty or to act on behalf of a particular duty, both general and specific, as a police officerwhose powers and duties are prescribed by lawor are acted in accordance with the authority specified by law tohave the authority and dutiesof the police. "Gifts, gifts or any other benefits affecting the performance of duties"means money, property, Any other services or benefits that are valued and include tips received bygovernmentofficials in addition to salary. Income, government benefits in normal cases and influence decisionmaking.approval or at the time of receipt or in the future. Article 2 Police officers at all levels shall behave. as follows1. Donot ask, lead, give or not accept bribes, gifts, gifts or any other benefitsfrom performing duties.2. Do not consentor knowingly allow family members to give or acceptbribes, gifts, gifts or any other benefits to those involved in the performance of duties.3. The performance of duties must adhere to fair law enforcement, takingadvantage of the interests and image of the police. Must not commit any act that mayconflict between personal and publicinterests, such as accepting gifts or personal interests, disclosing inside information, obstructing official hours for special work, etc.4. Reduce the giving or receipt of assets or other benefits by virtue according to the rules and amounts at the office. The NACC requires that expressions be made by signing greeting cards, greeting books, condolence cards, or using social media instead ofgiving items.5. He won't. Not tolerated. Not indifferent. In case of any violation found in the Superintendent/Station Supervisor as soon as possible. Article 3 The supervisor shall have the authority and duty to supervise, monitor and inspect the police officers under the subordinate to comply with this announcement. In case of any violation of this notice, report to the Superintendent/Station Chief as soon aspossible. Article 4 Any person found to be in violation of this Notice.

Article 5 In case of receiving complaints/clues Personnel affiliated with such offences at the police station will investigate the facts. If found guilty, the person who committed such act will be punished according to the law. and deliver the matter according to the hierarchy of command.
